## **Noteworthy Energy Talent Moves**

With profits for trading corporations across the wider energy sphere hitting new records last year, eyes were turning on Q1 2023 to see whether firms and the industry as a whole could potentially keep up this 'crazy' momentum. Whilst a significant portion of the explosion in profit could be linked directly to the volatility in trading oil/products – the combined profits of some of the top traditional heavyweight players hitting roughly \$199 billion last year - the dividends from trading in power and gas - with some citing LNG trading as the principal driver in profit by Q4 - also contributed to what represented a phenomenal year for energy prices throughout the entire spectrum. This due to the surge in prices which started roughly two years a prior - the combining of the effects of the COVID-19 crisis, volatility in meteorological conditions, wider macroeconomic uncertainty, plus the conflict in Ukraine which commenced mid-Q1 2022. Consequently, trading firms such as Vitol - which saw its LNG volumes rise to 17.6 million tons last year - continue to post incredible figures from the last twelve months - with the Dutch energy/commodity trader recording \$505 billion in revenue for last year – a jump of 80% from the year prior. As Q1 ended however, themes within the wider economic environment emerged that could see the energy trading sector encountering new turbulence - with most recently trading houses in Switzerland voicing concerns that the UBS acquisition of Credit Suisse could have a detrimental impact on the industry. Ultimately opinion is divided on this most recent phenomenon - some voicing that the perceived 'turmoil' as a result of the acquisition is likely to be limited in duration with only minimal effect to the wider economy, seeing demand for crude oil retain its recent skyward trajectory. Others suggest that those without the benefits of the established key connections held by the more substantial trading houses could see this most recent event as the precursor to a wider tightening on key suppliers/services. In terms of hiring, one resounding theme of Q1 is the continuing interest by hedge funds to bolster personnel in energy trading - with senior expertise in US Energy most recently held in highest esteem by those recruiting - hires in this region in the first four weeks of 2023 seemingly hitting new highs with reports of skyhigh signing bonuses being offered to bring on this expertise. Lastly, investment in environmental energy personnel - plus those with deep knowledge of the evolution of recent decarbonization incentives/focus - continues to see the number of senior hires in this sector rise - especially in the regions where demand for carbon offsets is more entrenched - however some reports state that whilst Asia's voluntary carbon market is currently less-developed, those recruiting in this region could likely see demand outrun much of the rest of the world in the short-term future.

In terms of hires recorded, Energy Q1 2023 saw an increase of 15.07% on the highest levels seen last year which was in Q2. EMEA saw the biggest jump over Q4 last year in terms of percentage held of worldwide hires – representing 42.85%.





## **Noteworthy Metals / Coal / Cement Talent Moves**

For the metal trading sphere - following the industry-upending nickel pricing low-point of Q1 which saw indices becoming disconnected from 'physical reality' - 2022 ended on something close to more solid ground following twelve 'wild' months. With restrictive deterrents to investing, the imposition of geo-political restrictions and the squeezing of supply networks - these preceding twelve months resulted in this sector being seen as one of the most unyielding to competitors - however driven on promising signs such as the optimism surrounding China's reopening offering a boost to base metals pricing plus the increasing number of trading outfits/financial institutions including Deutsche Bank seen openly bolstering their metals divisions' expertise through senior hires - sentiment seemed more opportunistic than nervous. With 2023 now beginning to unfold one of the central questions now lies within the disproportion of supply within certain metals – influencing how those who can secure depleting stockpiles can execute transactions at potentially even higher levels of return, whilst trying to minimise the 'melee' of risk to investors seen in recent times. Lithium and Nickel have recently been reported as being highly likely to hit constraints in supply by 2030 whilst more recently experts have told how they predict copper prices could rise by one third - potentially climbing to \$12,000 per metric ton in 2024 with inventories worldwide hitting their lowest levels in over fourteen years. One trend which started to emerge first in 2021 but continues to be present in recent months - is that of firms historically more well-entrenched in energy - spurred by the wider movements in the energy transition worldwide, plus holding the foresight surrounding the specific metals in question this would see in high demand in the coming years - subsequently building out desks trading in specific metals/making some of the most senior hires in this sector. Reports broke in Q1 that Hartree Partners LP was looking to make more hires for its metals-concentrate business which it formed three years prior - whilst news of hedge funds such as Millennium hiring senior personnel shows the wider level of interest being shown. Recent senior hires specifically within lithium/cobalt show clear intent surrounding the metals required for future-looking technology/the construction of electric vehicles which is now something in itself which the highest levels of energy trading firms are investing in/constructing new JVs for. This comes even whilst reports in February broke that cobalt was seeing a decline in pricing which first commenced in Q3 last year - with demand growth slowing despite an influx of new supply entering the market – a further sign of how competitors are being forced to consistently weigh the investment of their future designs with the current insecurity within pricing.

In terms of hires recorded, APAC saw the biggest jump in Q1 – eclipsing even the figure recorded for Q1 last year which was the most seen for the region in the whole of 2022. Hires in the US remained similar to those recorded in Q4 whilst EMEA dipped slightly by 11.00%.

## **Noteworthy Ags & Softs Talent Moves**

As within last year, the soft commodity sphere thus far in 2023 continues to be driven by the effects of the conflict in Ukraine. The significance of both Russia and Ukraine in terms of their exporting of raw agricultural commodity products is common knowledge. In 2021 – prior to the conflict – both regions were listed as one of the highest exporters of wheat, plus a multitude of other products across the soft commodity spectrum, whilst both were also occupying the position of pivotal components in terms of supplying fertilizer worldwide. The very end of 2021 had seen soft commodity prices start to climb but this then skyrocketed following the events of Q1 the following year. The concern now into 2023 rests on the extent to which the ongoing conflict continues to limit exports from both regions – with this inevitably then sculpting the widening supply divide growing throughout the world's grain markets, even whilst other exporting regions oversee their own efforts to invoke a hike in production – whilst coming to terms with their own domestic issues such as drought. The most successful trading firms in this sector – most often those with the opportunity to optimize freight or theorize more consistent levels of supply etc., continue to see most return through this turbulence. Key to this right now lies more than ever in meteorological precision, coupled

with a precise overview of how the volatility within energy pricing - still the key input in terms of physical production of soft products - is determining the economics of output/yield in real-time. Individual soft products are seeing differing fortunes so far in 2023. The pricing of wheat has been in something of a downward trend for several months consecutively - one of the worst performers even as robust demand continues to outstrip supply - whilst the pricing of sugar has doubled over the last twenty-four months, even though the surplus of sugar expected to be produced in the coming year is purported to limit this upside. As within metals, the soft commodity sphere is being viewed currently as one of immense potential in terms of bolstering existing trading talent or entering into as a new player. Last year ended on the reports that Vitol was to return to grain trading – the firm subsequently making multiple senior Swiss/Houston, TX-focus hires to this end since December. Within 2023, it has become clear that whilst trading firms such as Hartree Partners continue to make senior hires in this sector, hedge funds are also keen to exploit this sector's more finite pool of expertise - with the likes of Citadel LLC plus Squarepoint Capital LLP enticing senior personnel to join from the behemoths of the softs sector, long since to have considered to hold retention of the monopoly of senior personnel in recent times. Lastly, investment in new production technology or entering in to new/relatively nascent markets continues to hold key focus in terms of securing future success for soft commodity trading outfits. In February reports broke that Louis Dreyfus Company recently commenced operating as a trader in the Brazilian free energy market - reportedly intending to widen its activity in the sugar and ethanol market using energy from sugarcane biomass - citing 'competitive prices, predictability of on-demand contracting and the option for renewable energy sources,' as key to prompting this entry.

In terms of hires recorded, those worldwide for Q1 2023 were roughly similar to those recorded in Q4 last year – though with a noteworthy increase seen in the US. Interestingly whilst hires in APAC in Q4 last year represented 35.29% of those worldwide, this saw a decrease in Q1 to 23.52%, with a higher figure of the most senior hires found within US.



## **Noteworthy Shipping & Bunker Talent Moves**


As one of the components intrinsically linked to the wider volatility in the commodity sphere seen over the last twenty-four months – and ultimately the one 'domino' expected to keep up/drop in perfect timing within an evershifting picture of disruption in supply worldwide – it is no wonder that the wider shipping market entered 2023 with uncertainty and increasingly conflicted views on what to expect in the rest of this year. One only has to look at the short-term reports for the condition of the dry-bulk market moving forward this year to see this divided opinion – ultimately what is clear is that this is an industry which has been left close to impossible to predict in terms of immediate outlook. Looking deeper into the reports from within this sector in Q1/themes to expect for Q2, it is incredible to see the level of divergence – from talk of a market unquestionably 'under pressure' to one seeing a

recovery in 'full swing' - from talk of a market expected to see improvement weighted on China's re-opening - to one in for a 'rough ride' despite China's re-opening – to one that doesn't even need to consider the region in terms of its recovery - relying on demand growth for central exports to prop up the upturn independent of the region entirely. This level of conflicting viewpoints/uncertainty to commit to one theme is ultimately the result of everything the industry witnessed in 2022. Whether due to critical changes in grain flows due to the conflict in Ukraine or the energy crisis forcing a fundamental 're-think' of securing monopoly over heavily disrupted supply - the shipping industry was expected to consistently respond/evolve to unprecedented levels of shift throughout the entire year. As last year ended, the key issue for the shipping industry to contend with was the cost of delivering multiple commodity products plummeting through the skyrocketing energy prices in Europe 'throttling' economic growth worldwide - with multiple suppliers winding down production due to the cost of energy forcing the shutdown of producing/refining from the source. Couple this with the reportedly resounding insufficient investment in the groundwork or technology required for the industry to prepare fully for the transition to low-carbon energy – with the sector currently representing 2.9% of total carbon dioxide emissions worldwide - it's clear to see why the overall outlook could be perceived as an uphill struggle. Emerging in Q1 as the most recent issue to contend with is the higher interest rates forcing trading firms - and as consequence the shipping sector within this sphere - to revise/rework business models or pricing to ensure it doesn't leave itself exposed to losses. Successfully comprehending the current socioeconomic risks, whilst retaining a clear overview of an industry consistently under pressure to develop re-ordering of worldwide flow/geographical distribution of competitive resources is key to continuing despite potential further investment restrictions looming. There is optimism however in future growth and signs that some firms are betting on new opportunity moving forward - reports from the last couple of weeks state that NORDEN is to enter the Capesize Market whilst reports also broke that Heidmar is currently eyeing listing on NASDAQ, with plans to expand in dry bulk, technical management, plus S&P brokering.

In terms of hires recorded, Q3 last year still represents the worldwide high point of the last twenty-four months – though Q1 this year still represents an increase over hires recorded in Q1 2022. The bulk of hires recorded in Q1 were within EMEA – this region seeing an increase in percentage of worldwide total by 4.44% over Q4. The number of hires recorded in APAC remained close to those seen in the previous Quarter whilst the US recorded a decline.
